- b) The Pump House Project, highlighting events for over 50's, table tennis tables, crafty crew and next month will launch COGS. See their website for further information.
- c) Earth and Faith Tree Planting scheme, highlighting tree planting event in November, they are currently preparing publicity and leaflets, would like to hold an event in September to advertise the event within September green week, Town Council happily accepted an offer for a tree to be planted on their behalf.
- d) Community Learning Hub, highlighting successful community adult sessions in conjunction with Abingdon and Witney College, next step is to start courses with Community Champions in September, hopefully, also collaborating with the Pump House project.

14/2/21 Motion Under Notice (Members agreed to bring item forward in connection with item 8/2/21 c)

Members received and considered the following motion:

'To support Oxfordshire Green Week culminating in a Green Day event to be held at the Corn Exchange on September 25th 2021'

Cllr Swallow who would be lead Councillor for this event informed members that the event which will facilitate Earth and Faiths publicity of their event but would also bring/invite groups in Faringdon with an interest to come together with stands. Faringdon Town Council input would include free use of the Corn Exchange and use of kitchen for the day, setting up and clearing away, the co-ordination of groups and promotion. It was PROPOSED to support the motion and to place use of Corn Exchange on Facilities agenda. This was SECONDED and RESOLVED.

10/2/21 Community Engagement and Events

- d) Members considered a proposal for a Folk Festival in partnership with Folk Weekend Oxford. In October, in Market place, pubs, Faringdon Town Council was requested the use of the Corn Exchange for event in the day/evening. Members PROPOSED to support this event. This was SECONDED and RESOLVED.
- e) Members considered a proposal to hold a Mayors event in the town centre on Saturday 21st August. It was PROPOSED in principle to support this, deferring final decision to Chair of Community and Partnerships and Facilities. Mayor and Town Clerk details could be discussed. This was SECONDED and RESOLVED.

Members PROPOSED to delegate responsibility for the consideration of Youth Grants to the Grants Sub Committee. This was SECONDED and RESOLVED.

Members considered to work in partnership with SOFEA, the Foodbank and The Place to operate a Community Larder in the Corn Exchange, on Thursdays between 2.30pm and 4.30pm, from mid-September. Facilities Committee would need to approve a request to use the Corn Exchange is free of charge. The event would also have a café and possibly a repair workshop going forward and extending to Saturdays would be explored, if successful. Members PROPOSED to support this initiative.
