2. **C/Cllr. Thomas was elected as Chair**

6. **Minutes of the meetings: Friday 17<sup>th</sup> December 2021**  
Approved as a correct record.
7. **Constitution**  
The amended constitution, including representation and matters of interest for reporting back was AGREED
8. **Matters Arising**  
Faringdon 20mph project update:
  - Cllr.Morgan was concerned that 20mph won't be enforced. CH confirmed that 20mph would be enforced where there is a need.
  - There is concern that the 20mph will cause difficulty on major roads.
  - D/Cllr Ware felt that 20mph had not worked in Shrivenham. Speed watch has been introduced but is not publicised, so doesn't act as a deterrent. There was concern that speed watch was being carried out by a lone worker.
  - CH would circulate updated guidance.

**9. County Council Highways Officer's Update Report for Faringdon Area**

Little Coxwell and Great Coxwell have also applied for 20 mph  
Shrivenham in process of applying for 20mph.

Cllr. Ware:

- Requested a Shrivenham roundabout upgrade update – concerned that Swindon do not consider impact of development on Shrivenham or Faringdon
- Concerned about safe crossing for new primary school on Highworth Rd, Shrivenham
- Concerned about the state of roads and pavements in Shrivenham. Reports on fix my street not working. Cllr. Thomas suggested that Shrivenham explored the Super User programme.

**11. Faringdon District Councillor's Traffic Matters**

Cllr. Thomas updated:

- Electric Car Chargers being installed
- School safety around Junior School being investigated

**12. Great Coxwell Junction with the A420**

No current update

Cllr. Thomas will follow up to clarify traffic light installation dates.

**13. Faringdon Town Centre Pavements**

Cllr. Thomas informed the committee that this would hopefully be undertaken as soon as new budget is in place in April.

**14. Swan Lane**

ST updated that FTC had agreed to proceed with informal consultation to make the London Street end of Swan Lane one way. As soon as a map has been produced consultation will begin.

**15. Projects for CIL Funding**

To following projects from Faringdon Town Council for possible CIL funding from OCC were put forward:

- a) Safe crossing of A420 – possible crossing refuge being considered. A bridge would be the preference. ST to request a site visit from LT – to push for a linked plan with crossing. ST to talk to affected villages
- b) Opening roundabout at Stanford Rd for access to sports ground only. This is in the FNP. Currently people entering the sports ground need to go all the way round. Ask for a site visit with LT about opening this.

**16. Speeding**

- a) Considered 20MPH zones: –
  - FTC will consider expanding once Town Centre in place
  - Concerns about speeding on Coxwell Rd. Speed surveys to be undertaken:
    - Coxwell Rd
    - Ferndale Street
  - ST to request County speeding records from LT
- b) Considered use of speed indicator devices:
  - FTC would like to purchase two. Cllr. Thomas has agreed to fund one.

**17. Civil Parking Enforcement**

- a) Discussed implementation and progress:
  - Contact James Whiting for data.
- b) Received a request from Faringdon Town Council to implement residents' parking areas:
  - More investigation needed.
  - FTC are concerned that residents will not want this.
  - Will take it to the Town Meeting for consultation and discussion before submitting a request.
- c) Received a request from Faringdon Town Council for suggested changes and focus areas:
  - To be forwarded to LT and to request site visit.
