

**OXFORDSHIRE COUNTY COUNCIL
(FARINGDON) (SPEED LIMITS) ORDER 20****

The Oxfordshire County Council (“the Council”) in exercise of its powers under Sections 82, 83 & 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to that Act, hereby make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Faringdon) (Speed Limits) Order 202* and shall come into force on the day of 202*.
2. No person shall drive any vehicle at a speed in excess of 20 miles per hour in any of the lengths of road specified in Schedule 1 to this order.
3. No person shall drive any vehicle at a speed in excess of 30 miles per hour in any of the lengths of road specified in Schedule 2 to this order.
3. No speed limit imposed by this Order applies to a vehicle falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011, being a vehicle used for naval, military or air force purposes, when used in accordance with regulation 3(5) of those regulations.
4. The Oxfordshire County Council (Faringdon) (30 Miles Per Hour) (Speed Limit) Order 2022 is hereby revoked.

SCHEDULE 1

20mph Speed Limit Zone:

Each road within the centre of Faringdon town leading out to the following points:

<i>a)</i>	<i>A4095 Church Street</i>	<i>17 metres northeast of its junction with Swan Lane</i>
<i>b)</i>	<i>A4095 Gloucester Street</i>	<i>its junction with the A417 Lechlade Road</i>
<i>c)</i>	<i>London Street</i>	<i>6 metres east of its junction with Skinners Lane</i>
<i>d)</i>	<i>Marlborough Street</i>	<i>its junction with Bromsgrove</i>
<i>e)</i>	<i>Skinners Lane</i>	<i>its junction with Ferndale Street</i>
<i>f)</i>	<i>Southampton Street</i>	<i>its junction with Ferndale Street/Hart Avenue</i>

The whole length of every road in the parish of Faringdon (excluding the A420 Oxford-Swindon Road, and any roads specified in Schedule 2 of this order) extending in the case of the respective roads leading out of the parish to the following points:

a)	A4095 Radcot Road	a point 83 43 metres north of its junction with Church Street
b)	A417 Lechlade Road	a point 20 metres northwest of its junction with Wood View
c)	A417 Park Road	a point 45 metres east of its junction with Sands Hill
d)	B4019 Highworth Road	a point 196 metres northwest of its junction with Westland Road
e)	Coxwell Road	a point 25 metres south of its junction with Wearn Road
f)	Fernham Road	its junction with the A420 Oxford-Swindon road.
g)	London Street	a point 98 metres northeast of its junction with Sudbury Court
h)	Stanford Road	a point 47 metres southeast of its junction with Nursery View.

SCHEDULE 2

Roads subject to 30mph speed limit:

The whole length of every road in the town of Faringdon extending (in the case of the respective roads leading out of the said town) to the following points (excluding those lengths described in Schedule 1):

a)	<i>Coxwell Road</i>	<i>a point 281.5 metres south of its junction with Wearn Road.</i>
b)	<i>Fernham Road</i>	<i>its junction with the A420 Oxford-Swindon road.</i>
c)	<i>B4019 Highworth Road</i>	<i>a point 196 metres northwest of its junction with Westland Road</i>
d)	<i>A417 Lechlade Road</i>	<i>a point 232 metres northwest of its junction with Woodview</i>
e)	<i>London Street</i>	<i>a point 98 metres northeast of its junction with Sudbury Court</i>
f)	<i>A417 Park Road</i>	<i>a point 34 metres northwest of its junction with the A420</i>
g)	<i>A4095 Radcot Road</i>	<i>a point 83 metres north of its junction with Church Street</i>
h)	<i>Stanford Road</i>	<i>a point 47 metres southeast of its junction with Nursery View.</i>

a)	Coxwell Road	from a point 25 metres south of its junction with Wearn Road, southwards	for a distance of 257 metres.
b)	A417 Lechlade Road	from a point 20 metres northwest of its junction with Wood View, north-westwards	for a distance of 212 metres.
c)	A417 Park Road	from a point 45 metres east of its junction with Sands Hill, eastwards	to a point 34 metres northwest of its junction with the A420
