



Sally's Summary

Full Council Meeting 13th February 2023

The council received and considered the following three public questions relating to highway safety:

1. **How can families get urgent protection crossing Park Road to get to the new Primary School (Folly View) - particularly at the popular crossing point at the Volunteer Way Bus Stop?**
2. **How can crossing the A420 be made safer? Residents' suggestions:**
 - footpaths that cross the A420 between the roundabout and Little Coxwell turn
 - path connecting Faringdon Community College (FCC) to new Primary School
 - potential paths connecting new estates to the Leisure Park e.g. to tennis courts / cycle park
3. **How can we get a safety barrier at the end of the Fernham Road, where it meets the A420 opposite the Little Coxwell turn? Could this be a bridge for crossing?**

The council agreed with points made by all three residents. However, it was made clear that the town council have no authority regarding public highways, all three questions will be referred to the **Faringdon Area Traffic Advisory Committee to be held on 13th March at 10am** in the Jubilee Room at the Pump House, 5 Market Place, Faringdon.

Members received a response following their letter of concern regarding the **proposed loss of the Police Station on Marlborough Street**. They were informed that it will be sold subject to negotiations between Oxfordshire County Council (OCC) and Thames Valley Police (TVP) without detriment to the provision of either the local police or fire services. The Clerk will invite Matthew Barber, the Police and Crime Commissioner for Thames Valley, to attend a Faringdon Town Council (FTC) meeting. It will be investigated if the building can be registered as an Asset of Community Value, to protect it for community use and report to the next meeting.

Members APPROVED an application from to the County Councillors Priority Fund for a **replacement bench on the path to Folly Hill**.

It was agreed to extend the one day per week **Climate Change Officer** post to the end of August 2023.

Photo ID will be required to vote at polling stations at the **Local Elections on 4th May 2023**.



A Hedgerow removal notice was considered at **Church Walk**, Faringdon. The council asked for the hedge to be replaced or the loss of the length of hedge mitigated in some other way. Disappointingly, the town council have been informed that, following a site inspection, the Vale of White Horse District Council (VoWHDC) has determined the hedge does not qualify as 'important' under the criteria set out in Schedule 1 of the regulations. This means they will issue a decision letter raising no objections to the works to remove 5m of hedge.

The Clerk will, again, write to the landowners of **Henry Blake Way** highlighting potential dangers of lack of **pedestrian crossing**.

Cllr. Wise was elected to speak at a VoWHDC Planning meeting regarding **P22/V2053/RM** Land South of Park Road and put forward the town council's objections which centered around the height of a new care home, which is not in accordance with Faringdon Neighbourhood Plan. Cllr. Wise attended the meeting and stated the case but, disappointingly, this application has now been approved by the planning authority.

The recent large and bright orange **signage of Malvern Tyres** was discussed. The Clerk will write to VoWHDC enquiring about the lawfulness of the signage in a conservation area.

wire, silver work and use of gemstones. Generously, all proceeds from sales go to the charity Against Breast Cancer.

Twenty years ago, Laura's love of jewellery and dislike of waste lead her to start repairing and restyling broken pieces of jewellery so they could be fit for sale in the charity shop where she volunteered at -- she up-cycled even before the word was frequently used. It marked the beginning of the never-ending journey of learning new techniques, exploring new ideas and revisiting old ones. Materials are sourced in limited amounts, from donations or sometimes brought back from travels to Italy.
