A resident asked the following question:
How will Faringdon Town council ensure that isolated decisions on reduced parking in the Market Place, speed restrictions, and continued lack of parking enforcement on, namely Church Street, do not continually adversely affect residents of Church Street, Swan Lane and Coach Lane in Faringdon? i.e. Does the Town Council intend to take a consolidated approach to these issues or continue to deal with each issue in a silo method?

14/6/23 Faringdon Neighbourhood Plan

Members discussed the possibility of reviewing the Faringdon Neighbourhood Plan (FNP). Members PROPOSED, SECONDED and RESOLVED re-visit this after the council have adopted a strategic plan which may link to the content of a revised FNP.

15/6/23 Faringdon Area Traffic Advisory Committee

Members NOTED the minutes of a meeting held on 12th June 2023.

16/6/23 Fernham Road Footpath

Members received and considered an update and PROPOSED, SECONDED and RESOLVED to proceed with the purchase of a small section of land for pedestrian access across a ransom strip for £1.

17/6/23 Retail Park / Folly Park Bridge

Members received and considered an update. The Public Right of Way team are looking into access and permissions. There is £16,000 available from S106 funding and FTC may need to consider match funding to allow a path to join Folly Park car park.

18/6/23 Traffic Orders for Parking in the Town Centre

Members received and considered draft changes. It was PROPOSED to support the changes in the main but to request the stretches of parking along Church Street be extended to 1 hour. This was SECONDED and RESOLVED.

19/6/23 Speed Indicator Devices

- a) Members NOTED the update.
- b) Members NOTED the statistics. They indicate that the SIDs are working in terms of reducing the speed of cars and members agreed that it would be helpful to review the statistics regularly.

20/6/23 Vale Planning Surgeries

- 2) Safe crossing over the A420: re-iterate Neighbourhood Plan stipulation that, should any development take place at Wicklesham Quarry, a safe crossing of the A420 must be included.
