FTC Comment: application needs further detail
- c) [P23/V1766/HH](#) 5 Maple Road Faringdon SN7 8BD Resubmission of approved planning scheme: "Two storey side extension; single storey rear extension; garage conversion & alteration to existing driveway" (ref: P22/V0752/HH). Revised scheme to include a re-design of the rear extension.

- d) [P23/V1802/LDE](#) 5 Bowes House Lechlade Road Faringdon SN7 8AL Certificate of Lawfulness to determine whether the construction of part of the car parking spaces approved under P/13/V2301/O & P20/V3172/RM for the erection of 14 dwellings with associated access (which in combination form the planning permission) constitutes the lawful commencement of the planning permission.

FTC felt strongly that the facility needs to be a public asset, available for use by the public and other clubs at very reasonable rates.
