## **6. What Does Faringdon Need?**

Cllr. Castle led a discussion about what residents would like to see the Town Council do over the next four years. Residents suggested ideas such as:

- More Maypole dancing
- An extended programme of town events:
  - Specific (e.g Christmas) markets

- Repeat or similar to previous successful events such as the Blackbird Day and the Giraffe Walk.
- Possible long-term aspiration to create “living streets” and “low-traffic neighbourhood”, specifically in the Market Place.

### **7. Recreation Space in Faringdon**

Cllr. Castle led a discussion on current situation and future need for outdoor and indoor recreational space. The town needs extra space for outdoor sport – specifically a MUGA – sports such as netball, football, basketball, hockey all need more space in Faringdon. The idea of a community building was raised again and Cllr. Castle put out a call for ideas on available space or buildings.

### **8. Public Speaking Time and General Discussion**

A resident applauded the installation (by the District Council) of the electric car charging stations in the Southampton Street car park, noting that although not fully utilised yet, they are likely to be in the future, and they are therefore an asset to Faringdon. Cllr. Castle noted that although the Co-Wheels electric car project had not been given the go-ahead, other electric car hire clubs may be considered in the future subsequent to other towns pioneering the operation of such clubs.
