## 1/3/25 Apologies

Apologies for absence were NOTED from Cllr. Castle; Cllr. Wise

#### 2/3/25 Minutes of Meeting

Minutes of the meeting held on Monday 24<sup>th</sup> February 2025 were AGREED and SIGNED as a correct record.

#### 5/3/25 Members NOTED items for Information:

- a) Members NOTED the Action List
- b) Members NOTED that Oxfordshire County Council's ANPR proposals have been approved for Faringdon. Members NOTED that enforcement is of existing restrictions although businesses may have difficulties with deliveries if they are not by HGVs. Clerk to raise business/Royal Mail problems with Project Officer.
- c) Members NOTED meeting with Bellway Homes & Oxfordshire County Council re connectivity issues between estates.
- d) Members NOTED the Landowner Deposit for Sandshill including that new registered paths will need to go through a legal process.
