1/9/25 Apologies

Apologies for absence were NOTED from Cllr. Norris

2/9/25 Minutes of Meeting

Minutes of the meeting held on Monday 18th August 2025 were AGREED and SIGNED as a correct record.

3/9/25 Declarations of Interest

Cllr. Ford declared a personal interest in item 12/9/25 (d) and continued to participate in the agenda item

4/9/25 Public Participation Time

5/9/25 Members NOTED the Action List including

- a) Action list:
 - Grit bins: The Clerk will circulate map of grit bins so that Councillors can check those
 in their areas
 - Planning surgeries: the Clerk has booked the next 4 surgeries with the District Council planning department and the following list will be discussed:
 - Connectivity between housing; ransom strips; conservation area assessment; District Council future plans for leisure and community facilities for Faringdon.
 - The Clerk will circulate the notes from the recent Connectivity Working Party.

Members considered responding to the public consultation on the pre-submission version of the Shellingford Neighbourhood Plan and agreed to congratulate Shellingford and fully support their Neighbourhood Plan.
