Happy new year to you all, and welcome to the first county report for 2026. I am aware that there are several parish meetings this month. Please let me know of any concerns that you would like me to follow up.

Faringdon Town News

- **London Road/A420 Intersection Improvements:** This work is now complete, including the introduction of a traffic island to prevent overtaking and by the addition of red coloured surfacing, solar road studs and improved road markings to increase awareness of the junction.
- **Pedestrianising the Town Centre:** We met with officers to discuss options after December's FATAAC; we will be meeting with a consultant in January to discuss initial plans. This is a long-term project.
- **Adult Social Care (ASC) S106 Contribution:** I am continuing to pursue this matter with officers from Adult Social Care to investigate the best options for its spend.
- **Community Space Above the Library:** I received a request from Faringdon Historical Society to be granted further space above the library; officers are looking into this.
- **The Hobble:** This appears to have been cut back, but I still need to follow up with officers.
- **Councillor Priority Fund:** This is currently open, and applications are coming in.

Parish News

- **Consultation on the A417 Speed Limit Review:** This consultation is currently open, until January 16th and details circulated to local residents; I have responded supporting changes to the limits, mindful of the wishes of parishes. You still have time to contribute, closing on January 16th; the link is available in the consultations section below.
- **B4109 Resurfacing at Badbury Hill:** I have followed this up as it is a continual concern to residents. While work with adjacent landowners continues, and full resurfacing is a long way off, it is inspected monthly, and anything that meets the intervention level is picked up during these routine inspections; there is already a fix due by the 7th of January for a pothole in that area.
- **Drainage on the Holloway, Great Coxwell:** After chasing this up, I have had a report that the gully in this location was due to be cleaned by the 31st of December.
- **Repairs to the A4017, Eaton Hastings:** Reports on a large pothole on the A417 have been actioned and should now be rectified or programmed for works.
- **Old Hayes Solar Farm Application, Coleshill:** Submitted a response objecting to the development.
